## MANAGER'S COMMENTARY

Global equities were marginally positive during the month in sterling terms, with the MSCI ACWI index up 0.3%. Of the larger markets, North America was the top-performing region, while emerging markets once again suffered. Consumer staples led the field from a sector perspective, while industrials lagged at the back.

The company's NAV rose 0.3% over the month.

At a portfolio level, in absolute terms, the US manufacturer Leggett & Platt was the strongest performer. Although there appeared to be little newsflow driving the company's share price during the month, the stock has fared well following comments from the CEO which highlighted a good start to 2018 and the expected improvement in its bedding business throughout the year. US consumer goods multinational Proctor & Gamble also fared well. At a conference in mid-June the company's CFO reiterated that volume and value share trends continue to improve, highlighting that eight out of its 10 product categories are seeing positive organic sales growth in 2018. Meanwhile, Crown Castle (which owns, operates and leases shared wireless infrastructure) was another notable contributor.

On the other side, tyre company Continental was the worst performer. It continued to struggle following a profit warning it gave in April stating that first-half earnings would be impacted by exchange rate and inventory valuation effects. Added to this was also some uncertainty around the future structure of the company. Meanwhile, Chinese pharmaceutical Shanghai Fosun was also a drag on performance over fears that its medical diagnostics business could be impacted by trade tariffs. Luxury-goods company Richemont was another negative.

In terms of portfolio activity, we initiated a holding in Zurich Insurance and exited positions in Bank of Montreal and ING Group. Additionally, we sold put options in UK financial services multinational Prudential.
